AGREEMENT

Dijital Engagement is a duly licensed service providing a Disc Jockey and/or Master of Ceremony for social events and other occasions on an independent contractual basis.

Dijital Engagement and Customer do hereby stipulate and agree as follows:

Dijital Engagement will provide one Disc Jockey and/or Master of Ceremony (in most cases it will be one in the same), support crew as deemed necessary, all technical equipment to provide music and/or lights as required at the event location, subject to the following provisions and conditions:

1. Adequate space must be provided for equipment set-up (subject to inspection and approval).
2. Electrical outlets must be readily accessible and adequate (IIOV 2500W minimum).
3. If performance is to be outdoors, joint inspection must be made prior to event.
4. Location must be ready for set-up a minimum of one (1) hour before event.
5. Musical preferences or special instructions or requests must be provided in writing no less than two weeks prior to the event.
6. Customer, or third parties, in connection with any event, will not hold Dijital Engagement liable for any action or omission.
7. In the event of conditions beyond the control of Dijital Engagement such as: power failure, Acts of God, natural disasters, intervention by Police, Fire Dept. or other public officials, or other unpredictable stoppage of services being rendered, the Customer will be liable for FULL PAYMENT for services as agreed upon in this Agreement.
8. Returned checks are subject to a service fee of THIRTY DOLLARS (\$30.00) over and above the amount of the check plus recovery costs, if any.
9. Customer agrees to accept all responsibilities for loss and/or damage as a result of Customer requesting increases in volume of audio output above the limit deemed safe by representatives of Dijital Engagement.
10. Customer agrees to guarantee the physical safety of the Disc Jockey at your event. Customer will be responsible if the Disc Jockey is harmed by action of you, your invitees and any others attending your event.
11. Dijital Engagement has the authority to make last minute scheduling changes of Disc Jockey or Master of Ceremony due to illness or emergency.

CANCELLATION POLICY:

Customer retains the right to breach this agreement by canceling The Event. However, if you cancel this agreement we will be damaged thereby. Because of the time sensitive nature of entertainment bookings, it is difficult or impossible to estimate the damage that will result from your cancellation. Therefore, as a condition of this contract, you agree that if you cancel you will pay liquidated damages as follows: If you cancel more than ninety days prior to the performance date, you will pay as liquidated damages an amount equal to your deposit. If you cancel less than ninety days prior to performance and more than forty-five days prior then you agree to pay an amount equal to one half of the contracted amount. If you cancel less than forty-five days prior to performance then you agree to pay an amount equal to the Full contracted amount. We may retain your deposit and apply it against your charges. You agree to pay any amounts billed when you receive the bill. If you do not pay when promised, you agree to pay interest at a rate of 18% per annum.
